

Fall Semester 2005 Registration/Academic Calendar (revised 3/1/05)

NOTE: Any student who completes registration agrees to pay the University of Colorado at Boulder all charges on your account when due. (See bursar.colorado.edu/now/tuitfeebill.html)

March 14-24 (Mon.-Thurs.)	Fall 2005 course reservation registration period for eligible students. (See registrar.colorado.edu/Registration/Course.html)
March 28 (Mon.) - April 24 (Sun.)	Fall 2005 registration time assignments for students enrolled during spring 2005. For best course selection, register as soon as possible after your time assignment begins. Continuing students can register through May 27 (and also August 1-12).
April 25 (Mon.) - May 27 (Fri.)	Schedule adjustment for continuing degree students who have registered for fall semester and registration for continuing students who have not yet registered. AFTER May 27, continuing students may NOT register or adjust their schedules UNTIL August 1-12. Fall 2005 registration for eligible new graduate students and readmitted students who have confirmed with admissions and eligible students continuing from summer to fall. After May 27, readmitted students may not register or adjust their schedules until August 1-12.
May 30 (Mon.) - July 29 (Fri.)	Fall 2005 registration for incoming freshman and transfer students (<i>on specified dates</i>). Continuing students and readmitted undergraduate students may not register or adjust their schedules until August 1-12. Registration continues (<i>on specified dates</i>) for new graduate students and eligible students continuing from summer to fall.
July 29 (Fri.)	Deadline to update your billing and permanent addresses to ensure that your fall 2005 bill is mailed to the correct address.
August 1-12 (Mon.-Fri.)	Final registration and schedule adjustment for continuing students, new admitted graduate students and readmitted students who have confirmed, as well as eligible students continuing from summer to fall. Final registration period for all incoming freshman and transfer students who did not register in June or July (except those in arts and sciences attending the final orientation in August) and schedule adjustment for all transfers students who registered in June and July.
August 1-15 (Mon.-Mon.)	Bills mailed to the billing addresses of all students who register by August 12 (mailed on Mondays to all students who registered by the previous Friday). If no billing address is on record, bills are mailed to the permanent address.

<p>August 12 (Fri.)</p>	<p>Deadline for all students (except incoming freshmen and transfers in arts and sciences attending the final orientation in August) to register for fall courses. Registration must be completed by midnight on this day to be guaranteed enrollment for fall semester. After this date, registration is on a space-available basis, and a \$50 late fee is charged. (See registrar.colorado.edu/Registration/add-reg/late.html)</p> <p>Deadline (midnight) for continuing students to withdraw from the university and receive a full refund of the \$200 enrollment deposit, less any outstanding charges. (This deadline to withdraw and not forfeit the deposit also applies to students planning to go on the Time Out Program.) New and readmitted students are not eligible for a refund. (See registrar.colorado.edu/Support/Withdraw.html)</p>
<p>August 16 (Tues.)</p>	<p>Registration for incoming transfer students in arts and sciences who are attending the final transfer orientation on August 15-16, as well as registration for all other eligible incoming transfers who have not yet registered.</p>
<p>August 18 (Thurs.)</p>	<p>Registration for incoming freshman students in arts and sciences who are attending the final freshman orientation on August 16-18 as well as registration for all other eligible incoming freshmen and transfers who have not yet registered. These students must complete registration by 5:00 p.m. on this day to be guaranteed enrollment for fall semester. After this date, registration is on a space-available basis, and a \$50 late fee is charged. (See registrar.colorado.edu/Registration/add-reg/late.html)</p>
<p>August 19 (Fri.)</p>	<p>Drop/add time assignments begin for all incoming freshman and transfer students. (See registrar.colorado.edu/DropAdd/Default.html)</p> <p>ACCESS registration begins. (See www.colorado.edu/conted/access.htm)</p> <p>Bills mailed to the billing addresses all students who register August 15-18. If no billing address is on record, bills are mailed to the permanent address.</p>
<p>August 21 (Sun.)</p>	<p>Drop/add time assignments begin for all other students. (See registrar.colorado.edu/DropAdd/Default.html)</p> <p>Faculty/staff registration begins.</p>
<p>August 22 (Mon.)</p>	<p>Classes begin.</p>
<p>August 29-30 (Mon.-Tues.)</p>	<p>Space-available registration for Senior Citizens Auditors Program, Koenig Alumni Center, 9:00 a.m. to 3:00 p.m.; continues on Tuesday, August 30, 9:00 a.m. to noon. (See registrar.colorado.edu/Registration/add-reg/senior.html)</p>

<p>August 31 (Wed.)</p>	<p>Add Deadline:</p> <p>Deadline (5:00 p.m.) to add a course, including independent study and thesis, without the instructor’s signature. <i>After this date, the instructor’s signature is required on a special action form to add a course (through September 9).</i></p> <p>NOTE: After 5:00 p.m. on this date, web registration is only available for dropping courses (through 5:00 p.m. on September 7, the drop deadline). (See registrar.colorado.edu/DropAdd/Default.html)</p> <p>Wait List Deadline:</p> <p>Deadline (5:00 p.m.) to add name to a course wait list. (See registrar.colorado.edu/Registration/Waitlist.html)</p> <p>Tuition Payment Deadlines:</p> <p>Deadline to pay full tuition and fees (or first payment of two-payment plan). Due before 6:00 p.m. if paid in person or mailed, or before midnight using the internet payment option. No grace period. (See the bursar channel on CUConnect or bursar.colorado.edu/now/tuitfeebill.html)</p> <p>Deadline to sign up for the two-payment plan before midnight via CUConnect. No grace period.</p> <p>Deadline (5:00 p.m.) to select or waive university sponsored health insurance at Wardenburg Health Center or by midnight on CUConnect.</p> <p>Deadline (5:00 p.m.) for private scholarship checks to be received in the financial aid Scholarship Office to avoid late and service charges.</p>
<p>September 5 (Mon.)</p>	<p>Labor Day holiday. No classes. University closed.</p>
<p>September 7 (Wed.)</p>	<p>Drop Deadline:</p> <p>Deadline (5:00 p.m.) to drop a course without the instructor’s signature, without being assessed tuition and fees for that course, and without a <i>W</i> grade appearing on the transcript. <i>After this date, the instructor’s signature is required on a special action form and students must be passing the course to drop it.</i> (See registrar.colorado.edu/DropAdd/Default.html.) <i>No refunds for tuition or fees are given for courses dropped after this date.</i></p> <p>Deadline (5:00 p.m.) to petition to waive UCSU student fees.</p> <p>Deadline to request a refund of any student opportunities fees you selected.</p>

	<p>(See registrar.colorado.edu/Registration/Student.html)</p> <p>Deadline (5:00 p.m.) to withdraw from the university and only be assessed a \$200 withdrawal processing fee. After this date, 100 percent of tuition and fees is due for student who withdraw unless there are extenuating circumstances. (See registrar.colorado.edu/Support/Withdraw.html)</p>
September 9 (Fri.)	<p>Deadline (5:00 p.m.) to add a course without petitioning your dean. NOTE: Instructors' signature is required on a special action form to add a course. In general, instructors only approve an add if students have been regularly attending and there's space in the course. (See registrar.colorado.edu/DropAdd/Default.html)</p> <p>Deadline (5:00 p.m.) to change variable-credit hours, pass/fail, and no-credit status on courses. (See registrar.colorado.edu/Support/creditandgradingoptions.html)</p>
September 21 (Wed.)	<p>Deadline (5:00 p.m.) to withdraw from the university and be eligible to petition to be assessed 40 percent of full tuition and fees (instead of being assessed 100 percent of full tuition and fees). (See registrar.colorado.edu/Support/Withdraw.html)</p>
September 30 (Fri.)	<p>Deadline for students who have three or more final exams on the same day for fall semester to make arrangements to change their final exam schedule. (See http://registrar.colorado.edu/Calendar/examschedules.html)</p>
October 5 (Wed.)	<p>Deadline (5:00 p.m.) to drop a course without petitioning the dean's office. (See registrar.colorado.edu/DropAdd/Default.html)</p> <p>Deadline to pay unpaid balance (including two-payment plan). Due 5:00 p.m. if paid in person or mailed, or before midnight using the internet payment option. No grace period. (See bursar channel on CUConnect or bursar.colorado.edu/now/tuitfeebill.html)</p> <p>Deadline (5:00 p.m.) to turn in application(s) for the Course Forgiveness pilot program for fall semester. (See http://registrar.colorado.edu/Support/courseforgiveness.html)</p> <p>Deadline (5:00 p.m.) to withdraw from the university and be eligible to petition to be assessed 60 percent of full tuition and fees (instead of being assessed 100 percent of full tuition and fees). (See registrar.colorado.edu/Support/Withdraw.html)</p> <p>Deadline (5:00 p.m.) to turn in Time Out Program (TOP) applications to the registrar's office and be assured a continuing student registration time</p>

October 31 (Mon.) - November 27 (Sun.)	Spring 2006 registration period for continuing degree students enrolled during fall 2005.
November 22-23 (Tues.-Wed.)	Classes that normally meet on Thursday and Friday are instead held on Tuesday and Wednesday of this week due to the Thanksgiving holiday. (On Tuesday, November 22, students should follow their regular Thursday class schedule, and on Wednesday, November 23, students should follow their regular Friday class schedule.)
November 24-25 (Thurs.-Fri.)	Thanksgiving holiday. No classes. University closed.
November 28 (Mon.)	Spring 2006 registration begins for eligible new and readmitted students.
December 8 (Thurs.)	Last day of classes for fall 2005. Last day for students to withdraw from the University. Students in the colleges/schools of Architecture, Education, Engineering, Journalism, Law, MBA and Music must have their dean's permission to withdraw. (See http://registrar.colorado.edu/Support/Withdraw.html) Last day for students to turn in Time Out Program (TOP) applications to the registrar's office for fall semester. (See http://registrar.colorado.edu/Support/Timeout.html)
December 9-15 (Fri.-Thurs.)	Final exams for fall 2005. (There are no exams on Sunday, December 11.) (See http://registrar.colorado.edu/Calendar/examschedules.html)
December 15 (Thurs.)	Last day to dispute tuition and fee charges for fall withdrawals. (See http://bursar.colorado.edu/info/dispute.html)
December 16 (Fri.)	Fall 2005 commencement, Coors Events/Conference Center, 9:30 a.m.
January 16 (Mon.)	Martin Luther King, Jr. holiday. No classes. University closed.
January 17 (Tues.)	Spring 2006 classes begin.
